Books to be kept by the Secretary, or such person or persons. Members of the said Society, to be appointed for that purpole, amongst which shall be entered the Appointments of all Officers and the state of the Funds of the said Society from time time, as well those in the hands of their Treasurer or other Officers as those which shall be in any other hands whatsoever, and shall be signed by the said Members and all others who shall hereaster become Members thereof, and shall be open at every Quarterly Meeting for the inspection of any and every Member of the said Society, and all such Rules, Orders and Regulations so entered and signed, shall be deemed Original Orders, and shall be received in evidence, as such, in all disputes and in all Trials before the said Court of King's Bench.

Society may reseive Donations, entre vifs, or lega. cies of moveable or genional pro

XIII. And be it further enacted by the authority aforefaid, that it shall and may be lawful for the faid Society to receive Donations, entre vifs, or Legacies of Moveable or Personal, Property of any person or persons, for the support and increase of their faid Stock or Fund, and all fuch fum or fums of Money shall be applicable to the general purpoles of the faid Society in the like manner as the Contributions of the feveral Members of the faid Society are or shall be directed to be applied in pursuance of this Act, and shall not be applied in any other manner.

No finesto be imposed until fuch fines have been confirmed by the Court of King's Bench.

XIV. And be it further enacted by the authority aforesaid, that no Fines to be imposed under the authority of this Act, small be enforced, nor shall any proceedings be had, to compel payment of the same until the imposition of such Fines shall have been approved and confirmed among the other Orders, Rules and Regulations of the faid Society by the faid Court of King's Bench, and all such Fines, when and as the same shall be levied or received, shall be paid into the hands of His Majestyls Receiver General, and shall be accounted for to His Majesty, his Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury for the time being, in luch manner and form, as His Majesty, his Heirs and Successors shall be graciously pleased to direct.

Covernor em. powered to disfolve the Society.

XV. And be it further enacted by the authority aforesaid, that it shall and may be lawful at any time or times hereafter, to and for the Governor, Lieutenant Governor or person administering the Government of this Province for the time being, by and with the advice of His Majesty's Executive Council, either by Proclamation or by advertisement in the Quebec Gazette, to dissolve or determine such Society, and to annul and make void all the powers and authorities given to the faid Society by this Act, (except as herein after mentioned), as to such Governor, Lieutenant Governor or person administering the government of this Province and Council shall seem meet. Provided nevertheless, that notwithstanding any such dissolution or determination so to be contained in any such Proclamation or advertisement, it
