Suspected Ship.—A ship shall be regarded as suspected—

(1) If a case of human plague broke out on board in the first six days after embarkation;

(2) Or if investigations regarding rats have shown the existence of an unusual mortality without determining the cause thereof.

The ship shall continue to be regarded as suspected until it has been sublected to the measures prescribed by this Convention at a suitably equipped

Healthy Ship.—A ship shall be regarded as healthy, notwithstanding its having come from an infected port, if there has been no human or rat plague to board either the state of the on board either at the time of departure, or during the voyage, or on arrival, and the investigation the investigations regarding rats have not shown the existence of an unusual

ARTICLE 25

Plague-infected ships shall undergo the following measures:—

(1) Medical inspection;

(2) The sick shall immediately be disembarked and isolated; (3) All persons who have been in contact with the sick and those whom the port sanitary authority have reason to consider suspect shall be disembed to observation or disembarked if possible. Deratisation shall be carried out so as to avoid, as far as possible, damage to the ship and cargo (if any). The operation must not last longer the longer than twenty-four hours. Any charges made in respect of these operation operations of deratisation and any question of compensation for damage of deratisation and any question of the provisions of damage shall be determined in accordance with the provisions of Article 18.
