Inquiries of the Ministry

and Welfare. In view of the reports and statements made in the United States in respect of the incidence between smoking and lung cancer, can the minister say whether the research being carried on in his department, which he referred to on May 8 of this year, has reached the point where any report or statement can be made?

Hon. Paul Martin (Minister of National Health and Welfare): No such research is being carried on in the Department of National Health and Welfare, but various research bodies in Canada have been provided with funds out of the national health program to enable them to carry out research in various fields having to do with the health of the nation. That particular aspect of the matter is one subject that has been given consideration—not specifically, but along with others phases of cancer research.

Mr. Knowles: May I ask a supplementary question? Have any reports on this question been received from any of the bodies doing this research? If so, will the minister make those reports public?

Mr. Martin: I should have said that we are aware of studies that have been made particularly in the state of New York with regard to the incidence of cancer in relation to cigarette smoking. But as to any conclusions drawn therefrom, I do not think I can say anything at this time.

CANADIAN CITIZENS INTERVIEWED BY UNITED STATES FEDERAL BUREAU OF INVESTIGATION

On the orders of the day:

Hon. Stuart S. Garson (Minister of Justice): On December 1, the hon. member for Winnipeg North Centre (Mr. Knowles) directed a question to the Secretary of State for External Affairs (Mr. Pearson). The question asked whether there had been any instances, other than in the case of Igor Gouzenko, of the F.B.I. or any other United States agency interviewing Canadian citizens in Canada with respect to loyalty investigations in the United States.

My colleague, the Secretary of State for External Affairs, replied at once that he did not know of any instances similar to the one which the hon. gentleman has in mind, but he promised that the matter would be looked into and that if there were anything to report the report would be made at a later date. He then discussed this matter with me as the minister in charge of the Royal Canadian Mounted Police and requested me to reply to the question of the hon. member for Winnipeg North Centre in due course.
