Mr. Drew: Once again may I ask if any of the members of this house, in spite of the sounds they think it is appropriate to make under the circumstances, really think that any such proposal as this for the advancing of United States funds to finance a similar Canadian venture in the United States would even be heard on the floor of congress in Washing-Even the loudest and noisiest of the ton? members opposite knows perfectly well that any such proposal before the congress of the United States would be greeted with laughter that would be heard by the Americans on the D.E.W. line in the north.

Mr. Rowe: It would not even be heard on the streets of New York, let alone in congress.

Mr. Drew: I have said that the first issue raised is the authority of parliament itself, and that is before us in all its reality. Every hon. member knew that the agreement with Trans-Canada Pipe Lines called for the completion of its financing by April 30. Certainly it was of the utmost importance to the members of this house, and particularly to the government, that any alternative proposal should be made known and given consideration.
