## POST OFFICE DEPARTMENT

MONTREAL-REQUEST FOR REPORT ON MAIL TRUCK ROBBERIES

On the orders of the day:

Mr. J. A. McBain (Elgin): Mr. Speaker, in the absence of the Postmaster General I should like to direct my question to the Acting Postmaster General and ask whether he can give a report to the house on the robbery that occurred last evening in mid-town Montreal, in which it is reported that \$400,000 was stolen. Also, can he say if it is the policy of the department to leave mail trucks carrying as much as \$42 million unprotected by armed guards?

Hon. J. P. Deschatelets (Acting Postmaster General): Mr. Speaker, in the absence of the Postmaster General I might read a statement which covers this matter.

At 7.30 last evening the mail truck for the service between the Montreal post office and the C.N.R. station was held up at the corner of Lagauchetiere and University

The post office vehicle was boxed in at the traffic light and the railway mail clerk, who was accompanying the mail, and the truck driver were taken from the post office truck, handcuffed together, placed in one of the other trucks and pillow cases pulled over their heads.

The post office truck and the mail have not yet been located. The information indicates that there were 31 money packets on board the missing mail truck and some of them are believed to have contained payrolls. The matter is being investigated by senior officials of the Montreal city police and post office investigators.

This morning's press and radio indicate the amount of the loot as \$400,000, and have also indicated that mail trucks have carried as high as \$42 million on a trip. It is not known where the press and radio obtained this information, as an accurate amount of the loss will not be ascertained until the respective banks have been contacted, and I have no knowledge of any mail truck carrying \$42

million.

Moreover, Mr. Speaker, last night at 8.20 p.m. the highway motor vehicle service between Valleyfield and Montreal was held up at Caughnawaga. Two motor vehicles were involved in the hold-up and at least two armed men took part. The truck and mail have been recovered in this case but the locked bags have all been ripped open. Investigators are checking to ascertain the loss in this particular case, but it is not believed that any money packets were carried. The matter is being investigated by the Quebec provincial police.
