Mr. Speaker: Will the hon. member resume his seat. There is not perfect order in the house at this time, but I am sure the hon. member will be heard by the minister and the Chair if he asks his question now.

Mr. Scott (Danforth): Thank you, Mr. Speaker. I am trying to ask a question in my usual unprovocative manner.

Some hon. Members: Oh, oh.

Mr. Scott (Danforth): I should like to ask the minister whether, in view of Canada's continuing housing crisis and in view of the coming conference, the government has given any consideration to our request that members of opposition parties have a right to attend that conference if only in the capacity of observers.

Hon. J. R. Nicholson (Minister of Labour): Mr. Speaker, in reply to the part time member for Danforth—

Some hon. Members: Hear, hear.

Mr. Nicholson: —I will say that his suggestion will be considered.

Mr. Speaker: Order, please. May I as a corollary suggest to hon. members that this type of appellation is not in order. I suggest it is very close to being offensive to call a minister a part time minister or an hon. member a part time member. I suggest that all hon. members keep this in mind.

Mr. Scott (Danforth): Mr. Speaker, when I call the minister a part time minister I do not wish to suggest that I am casting any personal reflection whatsoever on him. We all know he is the Minister of Labour. We have objected to the fact that we do not have a full time minister of housing. It is no reflection by me, nor would I wish it to be so taken, upon the minister himself.

## BROADCASTING

IMPLEMENTATION OF CANADIAN POLICY

The house resumed, from Wednesday, November 1, consideration of the motion of Miss LaMarsh for the second reading of Bill No. C-163, to implement a broadcasting policy for Canada, to amend the Radio Act in consequence thereof and to enact other consequential and related provisions.

Mr. R. W. Prittie (Burnaby-Richmond): Mr. Speaker, I should like to summarize briefly a few of the things I said on this subject before the debate was adjourned on Wednesday. I referred to the new broadcasting act having in clause 2 (g) (iv) a reference to national unity. This is what the clause says:

the national broadcasting service should...contribute to the development of national unity and provide for a continuing expression of Canadian identity;
