

*Motions for Papers*

**Mr. Jack A. Irvine (London):** Mr. Speaker, I should like to ask the minister concerned, through you, when I might have an answer to question No. 1,675 which has been on the order paper since June 13 of last year.

Furthermore, I have not yet received an answer to starred question No. 2,086 which has been on the order paper since October 25 of last year. There is some information which I am desirous of obtaining, and I do not think it is a very difficult question to answer. I understand that starred questions are supposed to receive some semblance of priority.

**Mr. Andrew Brewin (Greenwood):** Mr. Speaker, I should also like to speak on a point of order and call the attention of the appropriate member of the government, who I believe in this case is the Minister of National Revenue, who is not here, to question No. 2,185 on the order paper which deals with a case before the tax appeal board and which was placed on the order paper by me on November 18 of last year. ## C.B.C.—APPLICATION OF LABOUR CODE

Motion No. 191—**Mr. Howard:**

That an order of the house do issue for a copy of all correspondence, telegrams or other documents exchanged between the Canadian Broadcasting Corporation, or any official thereof and any other person, group or organization, excepting any other department or agency of the government, relating to the application of the Canada Labour (Standards) Code or the deferment or suspension of any part thereof.

**Hon. Léo Cadieux (Associate Minister of National Defence):** Mr. Speaker, in the absence of the Secretary of State may I deal with this motion. I wish to inform the hon. member that there have been no correspondence, telegrams or other documents exchanged between the Canadian Broadcasting Corporation or any official thereof and any other person, group or organization relating to the application of the Canada Labour (Standards) Code or the deferment or suspension of any part thereof. Therefore I suggest to the hon. member that he might wish to withdraw his motion.
