- 2. The present members of the statute revision commission are: The Honourable Pierre Elliott Trudeau, PC., M.P., Minister of Justice and Attorney General of Canada. (member ex officio). Donald S. Maxwell, Q.C., Deputy Minister of Justice and Deputy Attorney General. Jean Miquelon, C.R., Deputy Registrar General of Canada. Rodrigue Bedard, C.R., Associate Deputy Minister of Justice. Donald S. Thorson, Q.C., Associate Deputy Minister of Justice. James W. Ryan, Director, Legislation Section, Department of Justice.
- 3. No records kept of the number of hours of meetings.
- 4. The Honourable Pierre Elliott Trudeau, P.C., M.P., is the present chairman of the commission.
- 5. The persons at present on the staff of the commission are: Mrs. Florence Rosenfeld, LL.B.; Mrs. Mary Lefebvre; Miss Carmen Morin; Mrs. Simone Gauthier; Mrs. M. E. Sarault.
- (a) and (b). Mrs. Rosenfeld began work on April 3rd, 1967, at a salary of \$12,000 per annum. Mrs. M. Lefebvre began work on July 17, 1965, and earns \$6,000 per annum as C.R. 5. Miss Carmen Morin began work on October 1, 1965, and earns \$6,000 per annum as a C.R. 5. Mrs. Simone Gauthier began work on November 1, 1966, and earns \$5,059 per annum as a C.R. 4. Mrs. M. E. Sarault began work on October 1, 1965, and earns \$4,494 per annum as ST 4. (c) Mrs. F. Rosenfeld is a graduate in law from the University of Manitoba and has practised law in British Columbia. She has worked as an editor for C.C.H. Limited, W. H. Anderson Company (Law Publishers), the Carter commission, and the Committee on Election Expenses.

- Mrs. M. Lefebvre was employed in the capacity of principal clerk by the revision commission for the 1952 revision. Miss Morin, Mrs. Gauthier and Mrs. Sarault are qualified in accordance with civil service requirements for the positions held.
- 6. No. One or two individual members of the commission have been considering the suitability of "Recueil des lois revisées du Canada" but have not raised the matter formally with the commission.
- 7. The commission intends that the Revised Statutes of Canada, 1967, be a bilingual edition.
- 8. No firm date can be given at this time. The commission will attempt to complete consolidation and report to the governor in council as soon as possible in 1968. It is hoped that promulgation and distribution will follow some time in the Fall of 1968.
- 9. No. There is no statutory authority for the continuing revision required for a looseleaf revision system.
