WHEAT-ACREAGE REDUCTION PROGRAM-LONG-TERM EFFECTS

Mr. Paul Yewchuk (Athabasca): My question is directed to the Prime Minister. Was the Minister of Agriculture stating government policy when he indicated he believed that the Lift program, which basically asks the farmers to give up one year of income, would have beneficial long-term effects?

Mr. Speaker: Order. The hon, member is seeking to confirm whether a statement made by a minister expressing an opinion or a belief, does in fact represent government policy. I have some difficulty considering this as a question which can be accepted procedurally. The hon, member might like to rephrase the question.

Mr. Yewchuk: I will try to rephrase the question, Mr. Speaker. Will the Prime Minister indicate whether he agrees that the principle of asking a farmer, through the Lift program, to give up one year of income is now government policy?

Right Hon. P. E. Trudeau (Prime Minister): No, it is not, Mr. Speaker. I am afraid the member does not understand the policy.

Mr. Yewchuk: I rise on a point of order, Mr. Speaker. A couple of nights ago the Minister of Agriculture indicated on television that he felt the Lift program, which basically asks the farmer to give up one year of income, will have beneficial long-term effects for the farmers involved. Does the Prime Minister agree with this?

Mr. Speaker: I had the impression this would be a supplementary question by the hon. member. I did not want to complicate matters. This is why I allowed the question. I was not sure if the hon. member was satisfied with the reply he received and a further supplementary question was allowed.

Mr. Yewchuk: Mr. Speaker, I want to try another supplementary. In view of the fact that the Minister of Agriculture has expressed the view that the Lift program, which asks the farmer to give up a year of income, will have beneficial, long-term effects. would the Prime Minister and his colleagues, as a show of faith in these people, be willing to give up one year of their income to see whether that will have beneficial long-term effects?

Mr. Trudeau: I repeat, Mr. Speaker, the hon. member obviously does not understand anything about the whole Lift program. The object is not to have the farmer give up a year of income but to have him curtail his production for a year and receive compensation. It is only \$100 million we are offering. I know this is only crumbs to the opposition; however, we think this is an important contribution to the farmer.
