# ALLEGED RACIAL DISCRIMINATION AT GOOSE BAY U.S. AIR FORCE BASE

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): Mr. Speaker, some days ago I directed a question to the Solicitor General regarding complaints by the National Association for the Advancement of Coloured Peoples concerning racial discrimination at the United States air force base at Goose Bay, Labrador. In view of the fact that Canadians have now expressed concern regarding the investigation by security police of the United States of Canadian girls who are dated by coloured servicemen, a fact which has now been confirmed by one of the American sergeants. I should like to ask the Solicitor General if he has looked into this matter and can give the House any report on the result of his investigation?

I am unable to confirm or deny the hon. member's allegations or the information he has but in any event I hope to be able to have a report on the matter brought forward.
