#### GOVERNMENT CONSIDERATION OF STOL AIRCRAFT AS FEEDER PLANES

# Question No. 1,388-Mr. MacDonald (Egmont):

1. What consideration is being given by the government to the participation in the development of STOL aircraft as feeder planes to areas of high population?

2. Has consultation been initiated with private companies with regard to the implementation of such a programme and, if so, which companies?

Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport): 1. Consideration and study are being given to all applications of STOL air transport systems in Canada. These applications include: (a) city-centre to city-centre; (b) regional, that is a service to improve transport and communication in less heavily populated areas: (c) feeder, including service from small centres to major urban centres and service connecting various centres to major airports, and (d) applications unique to northern areas of Canada. The announcement of a program to establish a demonstration service made on 13 May, is for a city centre service. Other applications will continue to receive examination and where it proves efficient and economical services may be introduced appropriate to these applications.

2. The Minister of Transport has met with groups from the Air Industries Association of Canada (AIAC) to discuss STOL programs and to hear the industries' views on a National Major Program. The AIAC represents most of the manufacturing companies in Canada who have an interest in STOL.

#### CANADIAN CONSTITUTION

FEDERAL POSITION ON CHANGES TO INCREASE PROVIN-CIAL JURISDICTION OVER SOCIAL SECURITY PROGRAMS

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to ask the Prime Minister whether he has agreed in principle that the federal government will accept constitutional changes increasing provincial jurisdiction with regard to income support and social service programs, or at least enlarging the area of the priority of provincial legislation in these fields?

Right Hon. P. E. Trudeau (Prime Minister): No, Mr. Speaker, no agreement has been reached with any of the provinces concerning any constitutional amendments beyond those which were mentioned in the communiqué of the February conference. Of course, as the Leader of the Opposition knows, there has been discussion by some provinces of amendments they would like to see made to the constitution, particularly concerning social security matters.

Mr. Stanfield: Is, therefore, the position of the federal government with regard to federal and provincial jurisdiction in the areas of income support and social service programs and the respective priority of federal and provincial jurisdiction in those areas the same as that set
