raise anything specific in my speech. I wonder if he could answer one specific matter that was in it and that is, in terms of other sponsorship, whether it be provincial government or industry or whatever, what success has there been and what projects will be funded in that way?

Mr. Stanbury: I think the hon. parliamentary secretary will be pleased to deal with that question, Mr. Speaker. The Secretary of State has certainly had that kind of participation very much in mind. As I was saying, there have been communications difficulties. Cheques are being requisitioned as contracts are returned and processed. Up to the present time, some 1,500 contracts have been returned by project groups, and 600 cheques have been requisitioned and 800 more will be by the end of the week. However, as is to be expected, with the many security precautions that must be followed when dealing with public moneys, there is an unavoidable time lag between receipt of a completed contract and issuance of a cheque. I should point out, Mr. Speaker, that banks and companies have been very good about making advance payments to groups once assured that money is coming. In some cases, the bank or company is being compensated directly.

Mr. Stanbury: Mr. Speaker, am I to gather that the opposition does not want to hear facts?

Mr. Baldwin: We want to hear facts, not propaganda.

The Acting Speaker (Mr. Laniel): Order, please. Is there unanimous consent?

Some hon. Members: Agreed.

Mr. Greene: Truth will come out, Mr. Speaker.

Mr. MacDonald (Egmont): Mr. Speaker, on a question of privilege, the Minister without Portfolio (Mr. Stanbury) claimed a moment ago that he was deprived of time because members of the opposition interrupted him. Some hon. Members: Oh, oh.
