Business of the House

Mr. Knowles (Winnipeg North Centre): Mr. Speaker, I have taken note of the items of business indicated, and where discussions are necessary we shall be glad to take part in them. I regret that the government House leader has still given no indication in respect of a bill to amend legislation affecting veterans. With reference to the observation of the hon. member for Grenville-Carleton (Mr. Baker) about the commodity tax review, I must say I am in somewhat of a quandary about making that reference. I understand the committee is dealing with the Bank Act and it has its hands full, so to speak. I will confer with the Minister of Finance (Mr. Chrétien) as to whether there would be any purpose in sending this item to the committee in light of the heavy workload presently before that particular committee.

Mr. Murta: On Thursday, February 15, the Minister of Agriculture (Mr. Whelan), in response to a question by the hon. member for Bellechasse (Mr. Lambert) with regard to the question of the salmonella epidemic in Quebec as it related to feed purchased for the feeding of cattle, said, as reported on page 3254 of *Hansard*:

—that it comes from the province of Manitoba. It is not just coming from the province of Quebec: it is associated with a wide, wide area in Canada—

That statement is wrong. The contaminated feed that was mentioned by the hon. member for Bellechasse did not come from the province of Manitoba.
