#### FOOD

SHORTAGE IN EUROPE—REQUEST FOR REMOVAL OF CEILINGS ON AGRICULTURAL PRODUCTS

On the orders of the day:

Hon. W. EARL ROWE (Dufferin-Simcoe): Mr. Speaker, in view of the critical food situation in Great Britain and Europe, and the almost starvation conditions in many zones, will the government give consideration to the removal of all price ceilings from agricultural products so as to restore production, which has been steadily declining in the last two years?

Some hon. MEMBERS: Answer.

Right Hon. W. L. MACKENZIE KING (Prime Minister): I might say for the Minister of Agriculture (Mr. Gardiner) that he evidently considers he is not the whole government.

Mr. CASE: That is news.

#### PUBLIC WORKS

WHARF FACILITIES AT NORTH SYDNEY, N.S.

On the orders of the day:

Hon. ALPHONSE FOURNIER (Minister of Public Works): Mr. Speaker, yesterday the hon. member for Cape Breton South (Mr. Gillis) inquired as to the intentions of the government concerning new wharfage facilities at North Sydney. His question was based on a telegram he had just received. The hon. member for Cape Breton North-Victoria (Mr. MacLean) had received a similar telegram at the same time, and handed me a copy of it so that I might make an investigation.

I understand that at North Sydney the government has two wharves, one of which was completed last year at a cost of \$500,000. Any new project contemplated for North Sydney would be part of the post-war reconstruction programme; and if the government decided to build a new wharf, an item would

appear in the estimates.

### BUTTER

INQUIRY AS TO DATE OF ESTABLISHMENT OF FLOOR PRICE

Right Hon. J. G. GARDINER (Minister of Agriculture): I must agree with the Prime Minister (Mr. Mackenzie King), that I cannot speak for the whole government.

REQUEST FOR AIR MAIL SERVICE BETWEEN WINNIPEG AND FLIN FLON

On the orders of the day:

Will the minister recommend that an air mail service be included in the new air service to begin June 1 between Winnipeg and Flin Flon via Dauphin and The Pas?
