Police Court.

The case of Joseph Riley, charged with breaking doors in Sable Paton's house on Sheffield street, was before the court this morning.

The case of assault was not taken up as Maggie Ross was not able to appear. Riley pleaded guilty to committing the assault, but not guilty to breaking the doors.

The case of Robert Bailey charged with trying to commit a rape upon Julia Kimball was taken up this morning.

Julia Kimball was the first witness examined. She is 14 years of age but told a very straight forward story. She said that on Sunday morning her father and mother had gone to the Salvation Army leaving her and her two brothers, aged 13 and 12 respectively in the house.

After they had gone out Reuben Bailey came in and having a cut finger asked her to tie it up. She was in the act of doing this when he knocked her down on the floor and attempted to commit the rape. She struggled with him violently and finally succeeded in escaping.

The witness who she named, while she was in the faint, Bailey carried her into the room and again tried to commit the act, but her two younger brothers, aged 13 and 12, who were in the room, heard him and he finally released her and she went to the kitchen.

Cross-examined by Mr. Baird, who appears for the defence, she stated that Miss Griffith was boarded by Bailey at the Kimball house, and that she and Bailey were engaged to be married.

She also stated that once before Bailey had attempted to commit the same act; also that her uncle had laid her on a bed, while drunk, and that she threatened to arrest him, but some how or other the matter was fixed up.

Jack Kimball will be the next witness called. When asked by the magistrate if he knew the nature of the oath, he stated that he did and that it was a sin to tell a lie and those who did could be burnt up. He corroborated his sister's evidence in every respect.

Cross-examined, he stated that his sister often took fish.

John Kimball, father of the girl, testified as to being told of the affair by his daughter on the morning, and causing the arrest of Bailey.

Mrs. Kimball, mother of the girl, corroborated the other evidence. After evidence was given Bailey was remanded until Monday.

Hugh McLade was before the court this morning on a charge of cruelty to a horse. It appears that above three weeks ago McLade received a horse from Chas. P. Lower to have it destroyed. He did not do so but instead took it to a barn where he kept it for some time. He was ordered by the magistrate to either have the horse destroyed or produce a certificate to that effect or appear this afternoon and answer the charge of cruelty to animals. He chose the former.
