Mr. MEIGHEN: This Bill is not of an important character. It provides for the acquirement of land earned under homestead by those who are refused naturalization only because they are unable to speak the English or the French language. There are one or two other minor provisions.

Motion agreed to, and Bill read the first time.

Hon. ARTHUR MEIGHEN (Minister of the Interior) moved:

That Bill No. 14 to amend the Indian Act be referred to a special committee composed of Messrs. Boys. Charlton. Davidson. Ethier. Lapointe, Lanctôt, Reid (Mackenzie), Stacey and Wilson (Saskatoon). for consideration thereof and all matters pertaining thereto, with power to call for papers, persons and records, to examine witnesses under oath, and to report from time to time, and for that purpose that Rule No. 11 be suspended.
