COPPER—SUBSIDIZING OF FOREIGN-OWNED COMPANIES UNDER NEW POLICY

I said at the time that 23,500 tons a month would be provided for Canadian fabricators, at a price of 59 cents per pound irrespective of their ownership. If there are other things I should read in the question I will be delighted to consult with my hon. friend after the question period.
