INFLATION—NATURE OF VOLUNTARY RESTRAINT GUIDELINES AND OTHER MEASURES—STEEL INQUIRY

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to ask the Prime Minister a question arising out of his various statements urging proper restraint upon the private sector of the economy. Has the government or the Prices and Incomes Commission yet decided on any guidelines as to what constitutes a proper exercise of restraint in present circumstances? If so, has any such information been conveyed, or will it be conveyed, to management and labour in addition to the general and proper exhortations in favour of restraint?

Right Hon. P. E. Trudeau (Prime Minister): Yes, of course, Mr. Speaker. The Prices and Incomes Commission has been consulting with management and labour for some time past, indicating to them ways in which restraints could be properly exercised and suggesting that the idea of a moratorium on increases in prices and incomes should be considered for the period of the next year. Details have been made known widely by the chairman and members of the commission. As I understand it, they have slated a meeting for December in which these suggested restraints will be
