If so, what is the determination in respect of the vote?

Hon. Mitchell Sharp (Secretary of State for External Affairs): The Canadian government will vote in favour of the Albanian resolution and will vote against all procedural motions which would prevent the United Nations taking a clear decision on the matter.

MONTREAL REHABILITATION PROJECT—LACK OF FEDERAL GOVERNMENT APPROVAL

POSITION OF AGREEMENT WITH NOVA SCOTIA— REQUEST FOR STATEMENT

Mr. J. M. Forrestall (Dartmouth-Halifax East): Mr. Speaker, this question is for the Minister of Regional Economic Expansion. Would the minister indicate whether or not the formality of the signing of the DREE agreement between the federal authority and the province of Nova Scotia has as yet taken place? If it has, would the minister be in a position to indicate at what stage some of the supplementary requests in respect of that agreement are?

Hon. Jean Marchand (Minister of Regional Economic Expansion): Is it possible, Mr. Speaker, to know to what agreement the hon. gentleman is referring?
