whole thing down the drain. There we could save quite a few million dollars.

### Mr. Nystrom: And the Senate.

Mr. Ellis: I have risen a number of times in this House to speak about the extravagant spending of the Department of Public Works, another department which spends over half a billion dollars per year. I can assure hon members that there would be not much trouble taking quite a few million dollars out of that budget. The cuts of the minister were phony from the beginning. They were taken from new estimates. Going back to Public Works, the example with which I am most familiar, in committee we did not have enough time to consider its estimates. There were two very short sessions and there was absolutely inadequate time, but in the few minutes we did have I can assure hon members that we found there were funds which could be cut back.

The budget promised restraint, but did absolutely nothing. I have the feeling that if there was an increase required in the per barrel cost of oil from \$6.50 to \$8, which would have put the price up by five or six cents, my neighbours in Ontario may not have objected to that. They understand the problems which exist.

Mr. Speaker, I see that you are ready to rise and it might be a good time for me to call it five o'clock. I will resume my remarks at eight o'clock this evening.

#### QUEBEC CIVIL CODE
