POLLUTION OF OTTAWA RIVER—MOTION UNDER S.O. 43

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. Considering that certain psychic disturbances characterized by irritability, shyness, tremors, coarse, jerky movements of the lips, tongue and extremities and, finally, gross inco-ordination, can sometimes be caused by mercury poisoning, considering also that a federal-provincial study on pollution levels in the Ottawa River, not yet released but known to exist, is reported to reveal high levels of phosphorous and mercury, both seriously hazardous to health, I move, seconded by the hon. member for Ottawa West (Mr. Francis):

That this House implores the minister for the environment, who admitted last April 19 in the House that he was aware of this particular report, to table the report forthwith so that residents on both sides of the river can understand the risks to their health and, in so doing, gather strong public support for all levels of government to intensify their efforts toward remedial action with better control to de-pollute the Ottawa River.

TRIBUTES TO LT. COL. DAVID V. CURRIE, V.C., ON RETIREMENT AS SERGEANT-AT-ARMS

Mr. Speaker: Hon. members will have noticed that today, as has been the case on almost every day that the House has been in session since January of 1960, the mace was carried into the chamber by a very distinguished Canadian, Lieutenant-Colonel David V. Currie, holder of the Victoria Cross, and the Sergeant-at-Arms of the House of Commons.

What is not well known is the range of responsibilities which touch the administration of the facilities which exist for members of the House of Commons, and that includes five buildings, two of which are under extensive renovation and all of which have to be provided with maintenance staff, security, all kinds of catering, restaurant facilities, and a whole range of services for which the Sergeant-at-Arms of the House of Commons bears full and total responsibility. I think I can say without fear of contradiction that any member of this House of Commons who has had the opportunity to travel to other legislative buildings around the world is able to return here and say that we rightfully take a very special pride in the first-class appearance and condition of these facilities which serve us in our work here in Ottawa.
