The Canada Post Act requires the Post Office to get an Order in Council before it closes a post office. This is to provide notice so there can be an appeal to the Minister. The Post Office and the Minister have both turned a blind eye to this legislation. When is the Government going to consult people? Or is it its plan to simply cut, cut, cut our postal services?

Canadians are awaiting legislation from the Minister of Justice (Mr. Crosbie). They do not want to be disappointed. They want strong and effective laws which will make this country a safer place for their children.

TIMISKAMING—BENEFITS ACHIEVED THROUGH ERDA AGREEMENT

Mr. John A. MacDougall (Timiskaming): Mr. Speaker, since our election in 1984 the Conservative Government has worked with the Province of Ontario to provide economic and regional development within the province. A number of ERDA agreements totalling \$226 million have been signed by the two levels of government. Part of this package is a \$30 million mining agreement signed in Kirkland Lake last June.
