SUGGESTION FORTY SEVEN MILLION DOLLARS OF MONTREAL PORT BE LEFT TO ADMINISTRATION OF THAT PORT—MOTION UNDER S.O. 43

Mr. Roch La Salle (Joliette): Mr. Speaker, under the provisions of Standing Order 43, I ask for the unanimous consent of the House to move a motion dealing with an important and urgent matter. I am sure it will be supported by all Montreal members.
