TRIED TO FO.CE CLOSURE

One of the Most Memorable Days in Canada's Parliament Closes in

Dr. Pugsley had finished his watch and gone home. The new rulings made it necessary to take up technicalities to hold off the vote.

Dr. Pugsley Saved the Day.

As Dr. Pugsley is the most experienced parliamentarian, and probably the ablest lawyer in the house, he was sent for. He got out of bed and in fifteen minutes was in the chamber. To his resource and capacity is chiefly due the Liberal success. Until midnight Saturday he was hardly out of the chamber. He raised point after point for debate, and was ably seconded in the discussion of these by F. B. Carvell and Hon. H. R. Emmerson.

When Chairman Robidoux, of Kent (N. B.), attempted to overlook speakers and close the debate, Dr. Pugsley stepped to the table and dared him to override the trukes in such a fashion. So determined was Dr. Pugsley that Mr. Robidoux faltered and recognized the speakers who were challenging his attempt. This was repeated a second time until Speaker Sproule had to take the chair and instruct Mr. Robidoux to close the debate.

The trouble came upon a point of order by Dr. Pugsley that Chairman Robidoux had been improperly appointed. He was given the seat at the table by Mr. Blain, who was named by the speaker to preside. Dr. Pugsley held that only the speaker could appoint Mr. Robidoux. The point of order had been discussed for several hours and at 10 o'clock in the evening Mr. Robidoux showed a disposition not to see members who desired to speak, and an inclination to give his ruling without turther debate. The Liberals began shouting "Gag" and "Recognize speakers" and the Conservatives shouted, "Give your ruling."


