MR. C. W. BUNTING IS DEAD.

A Well Known Figure in the Newspaper World of Canada Gone.

Deceased, who was fifty-eight years old, was born in Ireland. He came to Canada when a lad and learned the printing trade in the Globe office, but was in the wholesale grocery and other businesses for years. In 1878 he became manager of the Mail. He sat in parliament for Welland in 1878, but was defeated by Hon. Edward Blake in West Durham in 1882. A widow and several sons survive him.

SUCH NICE STATESMEN!

The Happy Family at Ottawa Had Another Mutual Administration Meeting.

When Hon. Mr. Clarke Wallace Called Hon. Dr. Montague Pretty Names.

Sir Mackenzie's Statement Prior Sworn in Controller of Inland Revenue.

Ottawa, Jan. 15.—Immediately after the Speaker took the chair yesterday afternoon the galleries filled rapidly and were soon packed to suffocation. People sweated in the crush for forty-five minutes, and the air was so oppressive that several ladies fainted. These people were attracted to the house by a report in the morning that a reconstruction of the government would be announced but they had their pains for nothing, for, after routine, Sir Adolphe Caron said he was unable to inform parliament as to the new government, but at 3 o'clock to-day he would give the full and definite programme of the reconstruction. He moved for an adjournment until then.

Clarke Wallace then rose and read a long statement reciting his connection with the anonymous letters from beginning to end. He read reports and documents referring to the letters, with the evident object of associating the authorship of the letters with Dr. Montague. An unpleasant incident was considered closed by Caron's acceptance of Montague's denial and the Governor-General's assurance of confidence, and in a vigorous speech Dr. Montague denounced Wallace for his unbecoming act in reopening the matter in such an unseemly and unstatesmanlike way. He said Mr. Wallace's statement was actuated by the same motive that prompted the writing of the anonymous letter, namely, a desire to ruin him (Montague) as a public man. Photographs of the letters would be distributed to members of parliament, and they could see for themselves that there was not a semblance of similarity between his handwriting and that in the anonymous letter. Sir A. P. Caron also regretted Mr. Wallace's course and considered it an insult to His Excellency.

In speaking to Mr. Caron's motion, Mr. Laurier said he would place no obstacles in the way of the prime minister, but would like to ask if certain gentlemen, who, a few days ago declared they could not serve under the present premier, had recanted and gone back to the fold. Sir A. P. Caron promised not to keep honorable gentlemen in suspense longer than three o'clock to-day.

In the senate yesterday, immediately after routine upon the orders of the day being called, Sir Mackenzie Bowell made the following statement: "I regret that I am not yet in a position to give the full information as to the reconstruction of the cabinet. It has, however, progressed to such an extent that I am safe in saying that I shall be enabled to meet the house to-morrow with a completely reconstructed cabinet, which I have every reason to believe will not only meet with the approval and support of both houses of parliament but also of the country. I therefore, crave the indulgence of the house for another 24 hours' delay. To-morrow, after making the report to which I have referred, I shall ask the house to proceed with the consideration of the address in reply to the speech from the throne, and commence the real business of the session. I, therefore, move that the house do now adjourn until to-morrow at 3 o'clock in the afternoon."

Later—Ottawa, Jan. 15.—The new cabinet deal is complete. All the portfolios remain the same as before disruption, excepting that Dickey takes the department of justice, Sir Charles Tupper the state department, and Desjardins the militia. Col. Prior has arrived and has been sworn in controller of inland revenue.

Ottawa, Jan. 1.—Sir A. P. Caron gave a statement to the house to-day showing that the differences between the premier and his colleagues were over, and that they were all caused by Mr. Caron's portfolio not being filled. Now that it was filled they all went back. (Laughter.) Col. Prior was introduced by Messrs. Munn and Dely when the house met to-day. He took the oath of privy councillor and that of controller of inland revenue to-day. Miall, commissioner of inland revenue, was going Col. Prior's duty before. The latter reached here, Miall reported to Mr. Costigan, who was acting minister of trade and commerce. Col. Prior reports to Ives.

BARNEY BARNATO'S BANK.

All is Rovey, But Shareholders Must Not Ask Any Questions.

London, Jan. 14.—At the statutory meeting of the Barnato bank to-day, a very large number of persons were present. Barney Barnato occupied the chair, in dealing with the assets of the bank, he said that three companies belonging to the bank could repay 90 per cent. of their capital, and others could repay their capital ten times over. Continuing, Mr. Barnato defended Mr. Cecil Rhodes, ex-premier of Cape Colony, and Dr. Jameson, leader of the raid into the Transvaal, saying he did not believe the invasion of the territory of the South African republic was proceeding.

Again referring to the affairs of the bank, Mr. Barnato said, in spite of the fact that they had gone through an unprecedented financial crisis, that the depreciation in South Africa had been from £120,000,000 to £130,000,000 during the last six months, the bank could declare a dividend of 25 per cent, which would have been doubled, under favorable circumstances. A vote of confidence in the chairman and directors of the Barnato bank was passed. After the vote had been passed some of the shareholders attempted to question Mr. Barnato, but he hurriedly adjourned the meeting, and with the directors, left the hall, from which they were followed by hooting and hisses.

A LIBERAL VICTORY. The "Wave of Liberalism" is Still Making Itself Felt in Eastern Canada.

M. C. Caron Captures West Huron Easily, and Adds Another Triumph to the List.

Goderich, Jan. 15.—M. C. Caron, the Liberal candidate, won in West Huron over Weismiller, Conservative, government candidate, by a large majority. This adds one more to the succession of defeats to the government in the by-elections. The result is regarded as most significant at this time, and presages an utter rout of the government at the approaching general elections.

PRUSSIA'S PARLIAMENT. Opened To-day.—Domestic Matters Only Mentioned in the Speech.

Berlin, Jan. 15.—The Prussian diet opened to-day in the White Hall of the Schloss. The speech from the throne is devoted to domestic affairs. The estimated budget for 1896 will show a smaller deficit than for 1895, owing to the increased railway receipts following the improvement in trade.

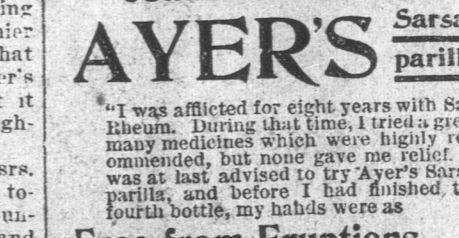
NANAIMO NEWS. The Civic Nominations—A Discouraging Day.
