

An Act to divide the Municipality of Gaspé Bay South and York, in the County of Gaspé, into two separate Municipalities.

**WHEREAS**, the Local Council of the "Municipality of Gaspé Bay <sup>Preamble-</sup> South and York," and the inhabitants of the Township of York, in the County and District of Gaspé, have severally by petition, prayed for the passing of an Act to separate the present Municipality of Gaspé Bay South and York, and to erect them into two separate Municipalities; and whereas, it is expedient, that their prayer be granted; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows :

10 **1.** From and after the *passing of this Act* the Townships of Gaspé Bay South and York, in the County of Gaspé, now forming one <sup>Two municipi-</sup> Municipality, shall be separated for Municipal purposes, and shall form <sup>palities</sup> two separate Municipalities under the name of "the Corporation of the <sup>formed.</sup> Municipality of Gaspé Bay South," and the "Corporation of the Mu- <sup>Names..</sup> nicipality of York."

15 <sup>The Municipality of Gaspé Bay South shall comprise all the</sup> territory included within the limits of the Township of "Gaspé Bay <sup>Gaspé Bay</sup> South," bounded on the north by the River Dartmouth and the north <sup>South de-</sup> west arm of Gaspé Bay, on the east by Gaspé Bay, on the south by <sup>scribed.</sup> Gaspé Basin and the river York and on the west by the western limit of the said Township of Gaspé Bay South, or Crown Lands. The inhabitants within the said Township, shall constitute a body politic and corporate, under the names of "the Corporation of the Municipality of Gaspé Bay South" for all Municipal purposes whatsoever.

20 **2.** The Municipality of York shall comprise all the territory included <sup>Municipality</sup> within the limits of the Township of York, bounded on the north by the <sup>of York de-</sup> River York and Gaspé Basin, on the east by the Township of Douglas, <sup>scribed.</sup> on the south by the southern limits of the said Township of York, or Crown Lands, and on the west by the western limit of the said Town-  
30 ship of York, or Crown Lands. The inhabitants within the said town-  
ship, shall constitute a body politic and corporate, under the name of "the Corporation of the Municipality of York," for all Municipal purposes whatsoever.

35 **3.** The Municipal Council of Gaspé Bay South shall remain consti- <sup>Council of</sup> tuted, as at present, with the exception of such of the Councillors as <sup>Gaspé Bay</sup> may be a resident in the new Municipality of York. <sup>South.</sup>

40 **2.** The said Municipal Council of York complying with the provisions <sup>Councils-</sup> of the Municipal Act, as regards the appointment of successors to the retiring <sup>of</sup> said Councillors retiring.
