I have directed the Public Accounts shall be prepared for your inspection; and, from the care, diligence and ability which has been faithfully employed in them, I

am persuaded they will prove correct, and be approved.

In your various situations you must have observed, and sound great convenience from, the improvements made in the Roads and Bridges; which, with the Public Buildings, tending to the comfort and credit of the country, so obviously and with such happy effect, that I rely on your wisdom and liberality to provide means for persecting these judicious objects of your former application.

The Estimate for the support of His Majesty's Government, shall be presented to you in time to expedite your consultations; wherein, and in whatever may facilitate the dispatch of the business of the Sessions with harmony and happiness, you may be

assured of my best exertions and ready concurrence.
