At the sounding of the Fire Signal -two short and one long blast from My wife shall dance and I will the Factory whistle-the foreman in each of the four floors, takes up an appointed position: all employees immediately drop work and line up twodeep behind him. A special squad of men open all approved exits and remain at their respective stations to preserve order. The employees are then marched orderly to the street. The foremen and men in charge of the drill are thoroughly instructed as to the number and position of exit in each department; a plan of each floor being furnished them. A fire brigade, independent of the "Safety First" committee, takes up special positions at fire buckets and hose line posts around the factory, and await instruction from the Chief Engineer who is in charge of the automati-
