City Council Will Take Action as Soon as Mayor Graham Returns.

BEST METHOD OF PROTECTING SUBURBS

Former City Engineer Graydon Says Huge Bank of Clay Should Be Erected All Around Low Lands.

A special meeting of the council will be called on Mayor Graham's return to discuss the West London

embankment. The situation, owing to the recent rains, is much worse than was an-ticipated, and it will be necessary to take some definite action at once to prevent a flood in the spring.

Mr. E. Pocock, representing the Vest London Progressive Society, was a caller at the mayor's office to day to urge that the meeting be held at once, but his worship had not re-turned from Ottawa, and he was informed that the meeting would be called the moment he returned.

up a clay bank.

"This could be done cheaply, and would be perfectly safe," he stated.

"Where a solid clay bank was erected, it has withstood the floods in excellent condition. If the board of works will erect now a clay bank where the points are weak, it will stand any flood without the slightest doubt. The people of West London are now raising such a howl should remember that they are as responsible for the present condition as council or any other body. will be remembered that when embankment was first broached, West Londoners informed the that the land needed for the breakwater belonged to them, and would cost nothing. The sum of \$15,000 was voted for the embankment. When we got started the residents of the suburb immediately put in claims for damages to property, with the sult that we had to pay out \$7,000 for land alone, leaving only \$8,000 for the breakwater itself. Had they acted fairly and expended the amount voted for the embankment, they would not now be worrying about its condition. 

TOWARD FEDERAL SOUTHE PLAN Charlie For, Local Businessman,

Militia Department Will Also Agree to Erect Large Addition to the Present Armories for Accommodation of Troops of Local Garrison.

CITY WILL NEED \$250,000 TO CARRY OUT THE BIG SCHEME

Mayor Graham Makes Official Announcement in Regard to the Larger Site for London's New City Hall—Ald. Coles May Yet Be Able to Put His Idea Through.

"The Government will give the city of London \$130,000 to purchase the McCormick and other property for a federal square, to Wellington, and King be bonded by Well Waterloo, Dundas and streets. Besides they will erect an addition to the armories with accommodate the permanent staff, now quartered over the Bank of British North America, and provide room for other regiments in city desiring quarters in the new building."

The above announcement was made y Mayor Graham and Ald. Coles this afternoon on their return from Ottawa, where they interviewed a number of the cabinet ministers on the question of a federal square. Both announce that the offer is definite, on the strength of it a bylaw will be submitted to the ratepayers in January next to raise debentures amounting to \$250,000 to complete the purchase of the land and provide for the erection of a city hall

Offer of \$130,000. "We met Hon, Sam, Hughes, and a

number of the other ministers," said his worship. "They were strongly in favor of the scheme, when it was explained to them, and made an offer of \$130,000 to assist us in the purhase of the necessary property. They have also decided to make the additions to the present armories.

"I think the offer an excellent one. The scheme is no small one. It has the value of being worthy of a city the size and importance of London. Ald. Coles and myself have figured that with the money we have in hand, we \$250,000 and \$300,000 for an additional \$250,000. A bylaw for that amount will be submitted to the ratepayers in January. The members of the Government urged us to put it through, declaring that this was the opportune time to carry such an excellent idea

TURKS MAKE LAST STAND CLOSE TO CONSTANTINOPLE

What Is Believed Will Be Final Combat of War Is Now Being Waged-Crack Turk Corps in Reserve for Last Ditch.

London, Nov. 8.—A great battle is in progress between the Bulgarians and Turks along the line of the Tchatalja fortifications, only some 25 miles outside of Constantinople. It is generally believed that this will be the last of the remarkable series of assessed value. One report received from Sofia last night said that the Bulgarians had occupied the Tchatalja line, but this remains without confirmation.

MISS JONES SAYS SHE IS PERSECUTED AND ILL-TREATED

West London Property Owner Declares Her Houses Were Wrongfully Condemned.

SAYS THE CITY HAS NOT NOTIFIED HER

Some Persons Have Started to Wreck the Terrace and She Is Disgusted.

Miss Harriet Jones, of 39 Kensington avenue, who is the owner of the five houses on Wilson avenue, which were recently condemned as being insanitary by Dr. Hutchinson, the medical health officer, was very emphatic in her denunciation of the city officials, when seen by a representative of The

Advertiser today. "The five houses nearly six weeks ago," stated Miss Jones, "but neither before nor after the action of the hoard of health did I or my agent receive notification of any ind from that body. All the word that we were given was the posting of the cards on the house and the notice to the tenants that they would nave to vacate the premises.

No Trouble. "The houses are nearly thirty years old, and my father bought them some twenty years ago, and until his death. two years since, they were kept in proper repair and no complaints have ever been made about them either by the tenants or city officials until recently. I have been trying to sell them for the past year, and have been so anxious to dispose of them that I memory has there been any epidemic of sickness or trouble of any kind in the houses, and I think the action of the board of health is totally unwarranted. It seems to me that it is persecution from beginning to end, particularly when one realizes that ten days ago my agent, Mr. Fitzgerald, wrote to the medical health officer and asked what requirements would have to be met to make houses sanitary and habitable, and as yet we have received no answer. I am certain that if it had spreading along the Tchatalja line, the fall of which might be expected at been a man that had owned the houses there would have been no action upon the part of the board of health and I

told Mr. Lutman so when I saw him Tenants Remain. this last effort to save the 42 and 48 Wilson avenue, are in good repair, having been papered, plastered and painted last June, and at the same time I had a carpenter repair the roofs of the five houses. The tenants of these houses, although ordered by the authorities to move, have not done so, as they can see no reason why they should have to leave the houses. These people cannot afford to pay a high rate

of rent, and their present dwellingplaces are satisfactory to them. Houses Damaged. "Yesterday as I was passing the houses on my way down-town I noticed that the empty house had been damaged to a great extent, but I do not know who is responsible. A large number of the panes of glass have been removed from the frames, and part of the woodshed of one of the places has been taken away. It does not appear to be the result of the pranks of the boys of the neighborhood, as they would break the glass rather than take it away whole, and it seems as if the woodshed had been demolished for firewood. I asked the police for protection some time ago, but in spite of this I have suffered quite a loss. It looks as if people think that because the places are condemned they have a perfect right to help themselves to anything about the premises which takes their

Glass Stolen That much damage has been done to the property of late can easily be seen from the street. In house No. 40, of eight panes of glass in the front of the house, six have been removed without being broken, and the other two show signs of having come in contact with a stone or other hard missile. Upon looking through the windows the observer can see that the paper has been torn off the walls, the doors broken, holes knocked through the partitions, and the rear doors broken open. From the outside, apart from the damage done by the unknown parties, the houses are very much similar in construction and general appearance
