Responding to the constant pressure of Labor's representatives for relief of the serious unemployment, the Government undertook to share with municipal corporations, under certain regulations, the expenditure incurred in providing employment relief between the first day of February, 1925, and the 15th day of April, 1925. The regulations provided that one-third of the excess cost over the usual labor cost incurred


