UNIVERSITIES RESEARCH SUPPORT

Question No. 2,208-Mr. Orlikow:

1. Which government department or agency is analysing the results of the Macdonald Report on federal research support in Canadian universities?

2. When is it anticipated that the review of the

above study will be completed?

- Mr. J. E. Walker (Parliamentary Secretary to the Prime Minister): I am informed by the Science Council and the Canada Council as follows: 1. Special Study No. 7 entitled "The Role of the Federal Government in Support Research in Canadian Universities" was prepared by a study group headed by Dr. J. B. Macdonald. The study was initiated by the Science Council and co-sponsored by the Canada Council. It is not a report to the government itself. Since the study identified over 40 departments and agencies of the federal government which, in various ways, provide support to university research, it is likely that most, if not all of these departments and agencies will be analysing the results of the study.
- 2. The Canada Council has indicated that they would be completing a review of the Macdonald study by mid-summer, and would likely publish a report on its findings shortly thereafter. The Canada Council has already reviewed the study and is presently in the process of distributing its comments to interested parties.
