Mr. Judd Buchanan (Parliamentary Secretary to Minister of Indian Affairs and Northern Development): 1. Yes, Sun Oil Company (U.S.A. controlled); B.P. Oil and Gas Ltd. (U.K. controlled); Deminex Canada Ltd. (West Germany controlled).

2. The specific details and terms of the agreements have not been officially disclosed, and are not on record in the Department.

3. Yes. Canadian Homestead Oils Limited (Canadian); Troy Oils Ltd. (Canadian); Toltec Mines Ltd. (Canadian).

4. The permits held by these companies were assigned directly to Panarctic Oils Ltd. by unconditional transfer, and details of agreements leading to the transfers were between the companies concerned and have not been officially disclosed.

ARGENTIA NAVAL BASE

Has the government made representations to the United States Government with a view to having certain recently vacated buildings, facilities etc. owned by that Government and situated at the Argentia Naval Base made available for use by the Government of Canada, the Newfoundland provincial Government or private interest and, if so, when were representations made and what were the results?

Hon. Mitchell Sharp (Secretary of State for External Affairs): The government has not made representations to the United States government on this subject but the matter has been discussed with U.S. officials by representatives of federal and provincial departments. These discussions have not yet indicated that there are any available buildings or facilities which could readily be put to productive use, although further studies of longterm development prospects are being made.
