Hon. Jean Marchand (Minister of Transport): No, not at the present time. There is no restriction on the recruitment of northerners in both the officer and unlicensed roles.

POLAR ICEBREAKER

Question No. 750-Mr. Forrestall:

- 1. What action has been taken towards funding research into the design of a polar icebreaker with 100,000 or more horsepower, with a capability of 10 to 12-month operation in the Canadian Archipelago?
- 2. Does the government consider research into such a vessel in the highest Canadian interest?
- 3. At what date does the government estimate that the need for such a vessel would render its construction imperative?

Hon. Jean Marchand (Minister of Transport): 1. Studies have been carried out on the form that icebreaking hulls should take. Presently a contract is being let to carry out studies on gas turbines and other types of power sources for propulsion of icebreakers. We are also providing, for instrumentation, some of our icebreaker hulls to determine actual ice pressures to which they are subjected. Additional studies will be entered into as the requirement arises.

INSURANCE FOR COMMERCIAL VESSELS

Question No. 754-Mr. Forrestall:

What arrangements, if any, have been made by the government to ensure the availability to commercial vessels in the Arctic waters of insurance at a reasonable or acceptable rate?

Hon. Jean Marchand (Minister of Transport): The government is not involved in the insurance business for commercial vessels. It has however a great interest and has provided voyages on our icebreakers, both in the Gulf of St. Lawrence and in the north, for representatives of the underwriters to allow them to observe firsthand the services which are available to ships operating in ice. By this and other means we are endeavouring to bring about rate reductions within the insurance industry.
