

The Expropriation Act.

In the Senate yesterday the Hon. David Mills introduced a bill to amend the Expropriation Act. This bill, he said, was complementary to the bill to amend the Exchequer Court Act. Its object was to enable the Crown in case of expropriation of lands for public vorks before the money was paid over for the expropriated land to abandon a certain portion of the land at first expropriated, or take only a limited estate for years in the land instead of a fee simple. If such abandonment or revestment takes place 'it shall be taken into account in computing the compensation for the land so appropriated. The bill was read a first time.
