A Bill intituled "An act to authorise the conviction and punishment, in a Summary Way, of persons committing common Assaults and Batteries."

And a bill intituled "An act for the further Security and Recovery of Monies due to his Majesty, upon Duties of Impost and Excise—and for regulating the Offices of Treasurer and Collector of Impost."

—PRAYERS.

Ordered, on motion of Mr. *Lewellin*, that the Account of Exports and Imports for the year ended 5th January, 1830; and the Account of Vessels belonging to this Island employed in the Foreign and Coasting Trade, and in Fishing, as received from the Custom House, be printed, and affixed to the printed Journal.

Read, as amended, the re-engrossed Bill intituled "An act to ascertain and establish the Boundary Lines of the several Counties and Townships of this Island—and to regulate the duty of Surveyors."

Ordered, that said Bill do pass, as amended.

Read, as amended, the re-engrossed Bill intituled "An act for providing Pounds within this Island—and to suspend an act made and passed in the 31st year of the reign of his late Majesty, intituled an act for providing Pounds in the several Royalities in this Province."

Ordered, that said Bill do pass, as amended.

Ordered, that Mr. *Mabey* do return the said Bills to the Council.

On motion, the House resolved itself into a committee of the whole House, on the consideration of granting a further Supply for the Public Service.

Mr. *Dalrymple*, Chairman of the committee, reported, that having taken into consideration the expediency of granting a further Supply for the Public Service, the committee had come to several Resolutions, which they directed him to report to the House—and he read the same in his place, and afterwards delivered them in at the Clerk's Table, where they were read, and are as follow:

1. RESOLVED,—That there be granted and paid to his Excellency the Lieutenant Governor, the sum of Three Hundred Pounds.

2. RESOLVED,—That there be granted the sum of One Thousand Pounds for the Contingent Expenses of the Government for the present year—to be drawn for, from time to time, by Warrant of his Excellency the Lieutenant Governor.

3. RESOLVED,—That there be granted, and placed at the disposal of the Lieutenant Governor, the sum of Eight Hundred Pounds, out of the present year's Revenue, for the erection of a Jail at Charlotte-Town—the said sum to be refunded to the General Revenue out of the Monies contemplated to be raised by a Bill intituled "An Act for raising a Fund, by an Assessment on Land, for erecting a Government House, and other Public Buildings within this Island."

4. RESOLVED,—That there be granted, and placed at the disposal of the Lieutenant Governor, the sum of Fifty Pounds, to defray incidental repairs on the Roads and Bridges.

The said Resolutions, upon the question being severally put thereon, were agreed to by the House.

On motion, the House resolved itself into a committee of the whole House, on the consideration of the bill intituled "An act for Appropriating certain monies therein mentioned, for the service of the year of our Lord One Thousand Eight Hundred and Thirty."
