BANFF-RECOMMENDATIONS OF ADVISORY COUNCIL

Inquiries of the Ministry

of Northern Affairs and National Resources. In view of the demand for the minister's resignation that was made at the regular session of the Banff advisory council last evening, could the minister indicate to the house the reason for such action on the part of this responsible body?

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): Mr. Speaker, I will first of all disappoint the hon, member by telling him that I have no intention of resigning. This is an advisory body. In the past we have thought that in these unorganized areas within our parks such bodies were good things. After the decision taken last evening I am going to be more cautious about the advice I accept from that particular body.

Two of the reasons given for the action were that we were running contrary to the Oberlander report, and were running contrary to recommendations of the land use code. On checking into the matter I find that in the allocation of this particular property for a motel we are following the Oberlander report completely, and in addition we are following the advice of the body involved in respect of the zoning plans. So I cannot understand how they can be so ill informed, and I shall be very careful about taking any advice from them in the future.

Mr. Dinsdale: A supplementary question, Mr. Speaker. Could the minister indicate whether the development on the Bow river site is in conformity with the recommendations of the Oberlander report with respect to proper land use? Further, could he indicate whether the opinion of the Banff advisory council was not confirmed by the interim development committee?

Mr. Laing: Mr. Speaker, I want to reply by stating that the Bowview lodge location is not presently zoned for motels, but the location is recommended zoned for motel use in the Oberlander report and the new land use code proposes this location should be zoned for motel use.
