DECISION NOT TO MAIL CHEQUES BEFORE CHRISTMAS

Mr. A. D. Hales (Wellington South): My question is addressed to the Minister of National Health and Welfare. I wonder if the minister has had an opportunity to consider and decide on the question I posed to him last Thursday. I asked the minister whether he could make possible the sending out of the December old age security cheques before, rather than after, Christmas.

Hon. A. J. MacEachen (Minister of National Health and Welfare): Mr. Speaker, this suggestion has been considered very sympathetically, but the conclusion is that by sending the cheques out at such an early date in December there would be a considerably greater than usual gap between receipts of cheques. Taking into account solely the welfare of pensioners, this suggestion was not felt to be feasible.

Mr. Hales: A supplementary question, Mr. Speaker. As I think this has been done before, and as there will be only a five week period between cheques, which is not unusual, will the minister not reconsider my request?

Mr. MacEachen: Mr. Speaker, my information is that, for the reason I mentioned, this has not been done before. It is not a question of not being sympathetic with the proposal or trying to beat it; it is a question of trying to take into account the best interests of most old age pensioners.
