Mr. Rondeau: Mr. Speaker, I have a supplementary question.

Since the minister has stated that he would initiate discussions with some detergent manufacturers in the United States, could he not also consult them about marketing at this time entirely biodegradable products, which are the only ones allowed in some American states?

Mr. Greene: Again, Mr. Speaker, the Canadian product is already biodegradable. I do not intend to have further consultations with the manufacturers as I think I did everything I could usefully have done in this regard. As indicated, I think governmental action is required, not a voluntary method of discipline.

[Later:]

Mr. Thomas S. Barnett (Comox-Alberni): Mr. Speaker, may I direct a supplementary question to the Minister of Energy, Mines and Resources on the matter of biodegradable detergents. Can the minister explain whether biodegradability applies only to non-phosphate components of detergents or also to phosphate components? I think this is an important question arising out of one asked earlier.

Mr. Greene: Mr. Speaker, I am not sure of the technical connotation of the question. It is my understanding that biodegradability was achieved by a voluntary process in which the companies co-operated some time ago. It was because of successes in that regard that I was encouraged to think that possibly we could achieve similar successes in the entire field of phosphates. The companies have taken the view that, (a) there is no substitute at the present and, (b) that the answer is to build or develop sewage disposal plants to clear up the phosphates rather than prevent their use, inasmuch as phosphates themselves are not harmful. They merely enable algae to live and grow. The companies feel that cleaning up after the use of phosphates would be the answer. I deemed, therefore, that I could not obtain the kind of co-operation with respect to phosphate control which had been obtained on the issue of biodegradability.
