IMMIGRATION

REGULATIONS CLASSIFYING JEWS FROM IRAQ, UNITED ARAB REPUBLIC AND SYRIA

Mr. R. Gordon L. Fairweather (Fundy-Royal): Mr. Speaker, I have a question for the Minister of Manpower and Immigration. Will Jews now in Iraq, the United Arab Republic and Syria be considered as refugees if they apply for immigration visas?

Hon. Allan J. MacEachen (Minister of Manpower and Immigration): Mr. Speaker, the persons to whom my hon. friend refers do not come within the ordinary definition of a refugee. They cannot be considered as such because they are still in their country of residence. Normally the accepted international definition of a refugee is a person who has left his country of origin and who is unwilling to return because of fear of persecution.

I would tell my hon. friend that we have had discussions with respect to the possibility of assisting the persons he has in mind. My colleague the Secretary of State for External Affairs and I have been collaborating in our discussions with the Canadian Jewish Congress.

Mr. Andrew Brewin (Greenwood): A supplementary question, Mr. Speaker. Is any consideration being given to setting out regulations on the subject of refugees, so that instead of dealing with each case as it arises there is a code to which reference might be made?

Mr. MacEachen: Mr. Speaker, I think that would be desirable. We have expressed our intention of adhering to the international convention on the protocol, and perhaps when the act is revised there ought to be a clear cut clarification of our over-all policy toward refugees. It is true that from time to time special arrangements have been made that I think, on balance, were of great advantage to the persons affected, and there may be some advantages in flexibility.

Mr. W. B. Nesbitt (Oxford): A supplementary question, Mr. Speaker. Can the minister tell the house whether United States deserters and draft dodgers are considered refugees?

Mr. Speaker: Order, please. I doubt whether that question is in order. If the minister thinks it ought to be answered, so be it.

Mr. MacEachen: The answer is no, Mr. Speaker.

DAIRYING—FAILURE OF COMMISSION TO REPLY TO CREAM PRODUCERS
