TABLING OF ADMINISTRATIVE BULLETINS NOS. 54 AND 78

Hon. Warren Allmand (Solicitor General): Mr. Speaker, following the request by the right hon. member for Prince Albert (Mr. Diefenbaker) on January 3, under Standing Order 41 I would like to table, in French and English, copies of RCMP administrative bulletins Nos. 54 and 78, as well as a copy of a letter I sent to the right hon. member explaining the contents of bulletin No. 78.

Mr. Diefenbaker: Mr. Speaker, I rise on a point of order. I asked for production of the various declarations that were made by the Royal Canadian Mounted Police, not an explanation of them, and I take the strongest possible objection to the minister filing self-serving explanations in a letter to me. If he wants to deal with this matter he can do so. I would be very happy to hear him explain on motions what took place, but that self-serving addition of his explanation of the unexplainable just cannot be justified.

Some hon. Members: Hear, hear!

Mr. Speaker: The Chair has some procedural reservations about what is proposed by the Solicitor General. The point made by the right hon. gentleman certainly deserves serious consideration. I wonder whether it is competent on a minister, under the Standing Order, to propose to table copies of a letter addressed to another member. I would think that a minister is always justified under the Standing Order in tabling what the Standing Order identifies as a document or paper, but I would doubt whether that would extend to an exchange of correspondence between a minister and a member.
