Cité du Havre, and Maison de Radio-Canada. In addition, there will be a telecine installation at Kingston.

2. With regard to individual costs, it has not been customary to require the CBC to supply such details of its internal management and administration. The total cost for the provision of host broadcasting facilities is estimated at \$50 million: \$25 million of this is being provided by the federal government and \$25 million by COJO.

3. The number of staff required to provide coverage for radio, film and television is estimated at 1,106, divided as follows: 649 from the CBC, 140 from the private sector, and 317 CBC-trained students. These staff members will undertake the ordering, installation, control, maintenance and supervision of equipment, as well as the processing, distribution and recording of the signals. No breakdown between radio and television can be made.

4. CBC/ORTO will provide facilities and services to 70 television and 110 radio broadcasting organizations. The cost of basic services—access to picture and sound from a comprehensive coverage of each event and access to adequate facilities for commentaries—will be covered by the \$50 million budget: special facilities will be provided to foreign broadcasters upon request, but the cost of these services will be completely recoverable.

5. Twenty mobile production units, 22 slow-motion units and ancillary equipment. Facilities provided in the old Radio-Canada Building are: a VTR room; a Quality Control Room; the Unilateral Master Control room; a maintenance shop; offices for participating broadcasters; 53 radio studios, a television distribution centre, an audio distribution centre; and nine television studios being either set up or modified in the three broadcasting centres (old Radio-Canada Building, International Broadcasting Centre and Maison de Radio-Canada).

GRANTS TO VAUDREUIL MUSEUM

Question No. 2,494-Mr. Herbert:

1. What grants were made in each of the past five years to the Vaudreuil Museum?

2. What grants have been indicated for future years subject to the necessary approvals?

Hon. James Hugh Faulkner (Secretary of State): I am informed by the National Museums of Canada as follows: 1 and 2. As part of the financial aid programs of National Museum Policy, National Museums of Canada has approved a contribution of \$80,000 to the Vaudreuil-Soulanges historical society for the Vaudreuil Museum. A first instalment of \$20,000 was paid during the 1974-75 fiscal year. Subject to approval by parliament of the necessary funds, a second instalment of \$30,000 will be paid in 1975-76 and the final instalment of \$30,000 will be paid in 1976-77. No other contribution has been approved or is being considered.

Lang (Minister of Justice): (a) To assist in researching housing legislation and preparing a lowincome cooperative housing information kit to be distributed to interested groups and organizations. (b) Grants for Research in the Legal Field. (c) The Treasury Board terms and conditions regulating "Grants for Research in the Legal Field" provide that grants may be made to: "bar societies; law professors, lawyers and other persons doing research in law; storefront legal offices and other organizations seeking to deliver legal services; associations engaged in innovative legal developments; and associations of law professors". (d) The purpose of the programme is to encourage research in the legal field. In assessing applications the Department takes into consideration the following guidelines: the subject matter must lie in an area of federal concern or must be of general application in the Canadian legal system; the publication for which funding is sought must not be commercially feasible; and the project must help solve some of the problems connected with access to information about the law.
