ONTARIO

Madam Speaker: It is my duty to inform the House that an objection signed by the Hon. Members for Kitchener (Mr. Lang), London-Middlesex (Mr. Bloomfield), Guelph (Mr. Schroder), Lac-Saint-Jean (Mr. Gimafel), Cochrane-Superior (Mr. Penner), Thunder Bay-Nipigon (Mr. Masters), Red Deer (Mr. Towers), Calgary North (Mr. Wright), Ontario (Mr. Fennell), and Scarborough Centre (Mr. Kelly) has been filed with me pursuant to Section 20 of the Electoral Boundaries Readjustment Act, Chapter E-2, R.S.C. 1970, to the Report of the Electoral Boundaries Commission for the Province of Ontario.

I would like to apologize to the Hon. Members who signed this objection since, through an administrative error, this objection was not announced to the House when it resumed its sitting on Monday. However, I am assured by the Hon. Member for Kitchener that these objections were filed within the time limit. Therefore, with the permission of the House, we will proceed with filing these objections. If the House agrees, I would suggest that we follow past practice and print the text of the objections as an appendix to this day's *Votes and Proceedings*.

Mr. Nielsen: Madam Speaker, I am afraid that in the hubbub that followed the Question Period and while you were making that statement from the Chair, I did not hear it all. With the permission of the House, you might provide me the courtesy of reading what you said and providing any necessary consent or observations tomorrow.

Madam Speaker: These are objections signed by the Hon. Members for Kitchener, London-Middlesex, Guelph, Lac-Saint-Jean, Cochrane-Superior, Thunder Bay-Nipigon, Red Deer, Calgary North, Ontario and Scarborough Centre. They have been filed with me pursuant to Section 20 of the Electoral Boundaries Readjustment Act, Chapter E-2, R.S.C. 1970 to the Report of the Electoral Boundaries Commission for the Province of Ontario.

I apologized to Hon. Members because these objections were not tabled in the House on the day that the House resumed its sitting. Apparently the objection was filed with the Clerk or with the Table, but for some reason that document was not seen by anyone. We were, therefore, not aware on the first day of the sitting that we had this particular document in our hands. The Hon. Member for Kitchener inquired about these objections. Upon research, we found the document.

The Hon. Member for Kitchener tells us that the document was filed on June 30. Therefore, as is customary, we take his word for that. I have therefore asked the House if I may file these objections and print the text in today's *Votes and Proceedings*.
