provision, if you will, so that the industry is not left high and dry like the aeronautic industry when a previous Conservative government decided to shut down the Avro Arrow?

Hon. Thomas Siddon (Minister of State for Science and Technology): Mr. Speaker, the connection drawn by the Hon. Member is totally specious, as he realizes. Indeed there is money available through the Department of Energy, Mines and Resources, the National Research Council, and other agencies. If proponents of projects in the solar energy industry would wish to come forward, their application would be considered alongside that of anyone else's. Following 10 years of funding under the existing program, which was already grandfathered for a second five-year period, we are not sufficiently convinced of progress to the extent that special allocated funding should be continued in this area.

INTERNMENT OF JAPANESE CANADIANS DURING WORLD WAR II—CONSIDERATION OF COMPENSATION

Given the fact that he promised throughout the campaign that a committee including Japanese-Canadians would monitor all alternatives for compensation, why are these considerations being undertaken in isolation from the Japanese-Canadian community?

Hon. Jack Murta (Minister of State (Multiculturalism)): Mr. Speaker, I do not know where the Hon. Member is getting his information from. Certainly if I were him I would go back and check my sources, because his question was not right. I can only reply to him that the matter is under active consideration by the Government at this time. He will be one of the first people to know about the decision when the Government makes it.
