All things considered, we can say that with the number of housing units available at the present time, 57,000 individuals can be assisted annually. With the housing bank, we expect 25,000 additional spaces will be available and perhaps better services for all concerned.

PROPOSED ESTABLISHMENT OF FINANCIAL SERVICES OMBUDSMAN POSITION

Mr. John R. Rodriguez (Nickel Belt): Mr. Speaker, my question is for the Minister of Consumer and Corporate Affairs in the absence of the Minister of State for Finance since the Minister has a direct responsibility and a legislative one for the benefit and welfare of consumers.

It is reported that the Minister of State for Finance is ready to embrace the NDP proposal in the bank service charges report—

Mr. Rodriguez: —for a financial services ombudsman who will be accessible to all consumers through a toll free number from coast to coast.

The Minister for Consumer Affairs has responsibility for consumers and he talks to the Minister of State for Finance. Is the Minister also prepared to support, in his discussions with the Minister of State for Finance, the NDP's further proposal that a financial services ombudsman ought to be independent and autonomous, someone who would combine the functions of referee and advocate? Is he prepared to support that proposal?

Mr. Wilson (Etobicoke Centre): I think the important thing about this committee report is that the report has been done in a non-partisan way and there are some good elements in the report which we want to study carefully before we accept or reject them. I know the Hon. Member is anxious that we move on this, but it has been only two days since the report was tabled, and I think that if he exercises his normal patience and forbearance we will be able to have a response to this report and we will advise him through the House in the ordinary course when that happens.
