TORONTO RAILWAY **CREATES NUISANCE**

First Appellate Court Holds Overcrowding Amounts to This.

POLICE BENEFIT WINS

Judgment of Mr. Justice Lennox Favoring John Welsh Reversed.

According to a judgment given out yesterday by the first appellate court at Osgoode Hall, he Toronto Street Railway has been found guilty of creating a public nuisance by allowing overcrowding on its cars. In confirm ing the conviction made by Mr. Jus-tice Riddell, in February, 1911, against which the appeal was made, the court expressed the hope that their decision would result in the stopping of over-

The court, however, held that the respondent's case completely failed and his action should have been dismissed by Mr. Justice Lennox.

Public Ownership Victory.

Public ownership in St. Catharines registered a big win when the first appellate count decided against the judgment of Chief Justice Falconbridge and maintained that the Hydro-Electric Commission of that town were entitled to utilize the poles of the Lincoln Electric Light and Power Co., without the company's consent and without paying for them.

The company argued that the com-

The company argued that the com-mission could use the poles for power to be used by the town itself, but it had no right to use them for the purpose of distributing power to custom-ers. According to the franchise the company was to allow the town to have free use of the poles for police and fire alarm systems and for carrying wares for the town's power or lighting.

By the terms of a judgment delivered by Mr. Justice Sutherland, it is pre-sumed that William Peacock of Hamilton, who went to Alaska in the gold rush and has not been heard of for 15 yeas, is dead. The sum of \$101.25, his share in his brother etate, will be ditributed among his heirs.

The appeal of R. Bulmer against the decision of Judge Denton, awarding Mrs McChee \$500 for injuries sustained when a bench collapsed at the defendant's refreshment stand, has been dismissed by the appellate division.
