2. For the twelve months ending January 15, 1907 :- Chinese, 59, of whom 55 remained in British Columbia; Japanese, 3,004, of whom 2,999 remained in British Columbia; Hindoos, 2,296, of whom 2,296 remained in

British Columbia.

For the twelve months ending January 15, 1906 :- Chinese, 10, of whom 10 remained in British Columbia; Japanese, 786, of whom 779 remained in British Columbia; Hindoos, 148, of whom 139 remaned in British Columbia.
