Mr. Speaker, it will always be possible to refer to clause 19(1)(g) to exclude a group of really undesirable individuals who are not welcomed in Canada. I therefore hope that the amendment will be agreed to and thus the harmful principle of guilt by association will be rejected as otherwise it would be sanctioned by the legislation. Mr. Speaker, we cannot speak of equality before the law in this country if the principle of guilt by association must apply to some individuals, while the majority of Canadians would not be subject to it, since the notion of guilt by association is squarely rejected in our statutes.
