Not long ago, the House, in the supplementary estimates, approved authority to the government to guarantee up to \$1.3 billion in loans by private sector companies to Canadair to help provide operating capital for the carrying out of its projects.

PRIVILEGE

MR. COLLENETTE—ALLEGED IMPUTING OF MOTIVES BY MR. THACKER—RULING BY MADAM SPEAKER

Madam Speaker: I would like to rule on the question of privilege which was raised by the hon. member for York East (Mr. Collenette). The hon. member raised a question of privilege alleging that on May 25 the hon. member for Lethbridge-Foothills (Mr. Thacker) imputed motives to Liberal backbenchers.

I just want to say that disrespectful or offensive language is covered by Standing Order 35 and that the unparliamentary words must be brought to the attention of the House by way of a point of order, not by way of a question of privilege. Therefore I cannot accept that the hon. member had the basis for a question of privilege.

Having examined what might have been a point of order, I looked at the words used by the hon. member for Lethbridge-Foothills. I found that he was not exactly addressing his remarks to any member individually. Erskine May says at page 430 of the Nineteenth Edition:

Expressions which are unparliamentary when applied to individuals are not always so considered when applied to a whole party.

In the words of my predecessor, Speaker Lamoureux, I would say that these kinds of exchanges are part of the political life of the House. However, I would urge hon members to try to use language that is acceptable to all members on all sides of the House.
