I., Lewis, who, with Ward Stanworth is acting for the defence, submitted certain statements, which were founded on an investigation made by him. He claimed that Toulouse's given name is Raymond, and not Albert; information which he had gained by recourse to the books at the Registry Office. Toulouse, he said, did not promise to marry the girl nor buy her a wedding ring, as alleged. He did buy her a small ring, but not a wedding ring. The girl had coaxed him to come with her, and the offence had not been committed under any false pretences. The court replied that if these statements could be proved, they would be duly taken into consideration.

The influx of Japanese is not nearly so great as the despatches from British Columbia would indicate. For the seven months ending July last the total arrivals of Japanese in British Columbia were 4,121, but of this number 1,147 were in transit for United States ports and 429 were merchants and others who had been in Canada before. The total arrivals of actual immigrants at British Columbia ports was, therefore, only 2,545 up to the end of July. Figures for the month of August are not yet available.

The wholesale purchase of firearms by Japanese and Chinese yesterday was stopped by assurances made to the Japs by Consul Morikawa; nor do the Chinese place any reliance in the statements of the police.

City Solicitor Cowan has ordered all hardware and sporting dealers to stop selling to Celestials. Four large boxes of arms, purchased from different firms in New Westminster, were seized by the police and taken to the police station, where they are now held.

Victoria, B. C., Sept. 11.—Steamer Monteagle arrived here last night with 1,164 Asiatics, all booked for Vancouver. She will leave Victoris at midnight and endeavor to land passengers before it is generally known in Vancouver. The list includes 901 Hindoos, 149 Chinese, 114 Japanese.

### TRAIN WENT TOO FAST

on Caledon Wreck **Victims** 

Japanese Consul-General Express Was Travelling Like A Streak of Lightning

R. B. Hendry of Orangewille, the first witness after the noon adjournment, testified that he was a passenger on the wrecked train. He got on at Orangeville and was in the fourth car from the engine.

"The train was going very fast," he said, "and I remarked to a passenger beside me that we would soon be in Toronto if they kept up this gait."

"I knew every foot of the road," he continued, "and I can say positively that no brakes were applied, as is the usual case, when we came to the top of the curve. I jumped for the door and grabbed the knob, I was so frightened. The door came open with me and I got out. I rushed to the assistance of the two Patterson girls and Miss Connern of Orangeville. Miss Patterson was wedged in, hanging by her feet to the top of the third car, which turned turtle and she called to me that her sister was dying beneath her, pinned under a mass."

Speed Excessive.

Dr. Graham of Mono Road testified to the identification of the five vic-tims, and Dr. Thomas Allison said that the death of all was due to the accident from which they had been

accident from which they had been taken.

### FOWL ARE POISONED

Mayor of Vancouver Asked Evidence Given at Inquest Dog Destroyer Now Turns Attention To Chickens And Ducks

> Grows Bolder In Belief That He is Safe From

The dog-poisoner has apparently takes up a new field of labor, and is now busy poisoning chickens. At least chickens belonging to Robert Cucksey, Queen St., are dying one by one, and the symptoms appear to be those of poisoning. Nine of these chickens died on Monday, others have died since and several of the remainder of the flock are very sick to-day. It is said that the chickens never left Mr. Cucksey's lawn, so the poison must have been distributed there in order for them to get it.

Veterinary Surgeon Kime and Officer Peter Dezelia opened up several of the dead chickens, and found their crops to be filled with fat meat, chopped up in very small pieces. An analysis of this meat will be made to-day to find if there be any strocking poison in it, as supany strychnine poison in it, as
