FORTY PLUMBERS FINED

\$10,600 Contribution to the Provincial Government.

Penalties Ranging From \$200 to \$500 Inflicted by Chancellor Boyd Upon Members of the Plumbers' Association Who Received Dividends-One Hundred Allowed to Go on Suspend ed Sentence-Names and Penalties.

Hundred Allowed to Go on Suspended Sentence—Names and Penalties.

Toronto, Jan. 16.—After an important address on the issues of the now celebrated plumbers' conspiracy case, Chancellor Boyd brought the whole matter to a conclusion yesterday morning with the exception of a few scattered threads, when he inflicted fines varying from \$100 to \$500 on forty members of the Master Plumbers' Association individually charged with conspiracy. In all \$10,600 will be paid in to Sheriff Mowat by those thus punished for their connection with the combine. Of the remainder of those charged about 100 were released on suspended sentence.

Method of Assessing Fines.

In his remarks on the method adopted by himself in assessing the fines the Chancellor explained the reason for this discrimination. From his examination of the documents he discovered those who had received sums of money from the association. As far as was possible, therefore, he had levied such fines that these amounts would be handed over to the Crown as a penalty for the breach of the law. The Chancellor was also influenced by the fact that many of the lesser tradesmen had reaped no great advantage from their connection with the monopoly, but had been forced into it by their more powerful competitors.

Erred On Side of Clemency.

However, he expressed the opinion that while he would follow the scale of fines set by Mr. Justice Clute in the first case, yet he felt that the latter had erred on the side of clemency.

In regard to those who had plended guilty of receiving bonuses on the contracts for work done for Warwick Bros. and Rutter, the Toronto Bedding Co., the Homewood Sanatarium, Guelph, the Toronto Isolation Hospital and others, the judge decided to allow the culprits to depart on suspended sentence. He did this on the understanding that restitution had been made and that there would be so further recourse to such methods.

CLOSE CALLS

Narrow Escapes in Explosion at the Blacksmith Shop of the Gray Factory

Yesterday morning about half past ten an explosion occurred in the blacksmith shop of Wm. Gray & Sons Co. A blast pipe serving one of the furnaces with air, presumably filled with gas while the machinery was temporarily stopped and when the draught started up again the compressed air and gas in the pipe exploded.

About twenty-four feet of piping

About twenty-four feet of piping was ripped and pieces were hurled about the shop.

The blacksmith at the furnace had a close call, as a large piece of heavy piping about ten feet long was hurled post his head and settled in a corner about eight feet away, smashing a window.

One of the drill hands had just left his post on account of the machinery being stopped, and when the accident took place a heavy jagged piece of metal was found where he had been sitting but a moment be-
